In case there are expenses in the mentioned transfer, the subscriber must be responsible for such expenses.
  - (b) Payment by a crossed cheque, cashier cheque, draft, bill of exchange, or bank's payment order collectible in Bangkok within 1 business day from each notification date, made payable to "KCE Electronics Public Company Limited for Share Subscription by Warrant". The exercise shall be valid only if the payment is collectible.
